Several categories were added and/or changed:

- Education/Grants we removed grants and shifted them to Misc./Donation and then added Expo to
  Education since they have been lumped together for a while and it will clarify things at Board of
  Governors.
- Team Competition was added as a separate line item since RMDS is taking over the management of the competition. All of the RMDS shows are currently separate line items, so this follows the policy.
- Adult Amateurs were given a separate line item similar to Jr/YR program. This line item will include the AA camps and other programs offered.

Starting from the top and working down, here are the suggested changes to be presented at the Board of Governors meeting.

- BOG Awards Income increase to \$350, reflecting increased postage reimbursement; Expenses were suggested to remain the same due to fewer trophy repairs and fewer new trophies.
- BOG Banquet Increase both income and expenses to reflect actuals.
- Centaur Remain the same based on actuals.
- Central Office Increase Income due to email blasts. Increase expense due to increased salary for Office Manager.
- Championships/Breed Show Increase Income based on actuals, same for expenses, but hoping with sponsorships for a greater profit.
- Clinics Decrease both Income and Expense due to the removal of the AA clinic and Junior Camp to the new AA category and Jr/YR program respectively.
- Education/Expo Changed Income to \$0 with the removal of the donations to the Misc/Donation category. Expenses decreased to the actual costs of the Expo registration plus promotional materials.
- General/Interest Unchanged
- Jr/YR Program Increase Income and Expense to include the Junior Camp. Since the camp has made money over the last several years, the Net Change has been made profitable.
- Marketing Unchanged
- Membership Dues Decrease Income to reflect decreased membership over the last few years. This decreases the Expenses since we won't report as many members to USDF.
- Membership Horses Unchanged. Registrations remain similar over the years.
- Misc/Donations Sharon will look up the Income some questions arose as to what was contained here. Expenses include the following: \$2000 Paragon show, \$1000 Region 5 FEI Jr/YR program, \$500 Dressage Foundation, \$1000 RMDS Scholarship fund.
- Omnibus Increased Income due to new color tab availability. Decrease expenses since there are hardly any new tests and thus there will be fewer hours billed.
- Operating Decreases Expenses to reflect actuals.
- Scheduling/Insurance Unchanged.
- Scholarship Increase Income to reflect actuals.
- Taxes/Legal Unchanged.
- Website Unchanged.
- Winter Wake-Up Show Unchanged. No committed sponsorship at this point this year so there is some work to do here, but hopefully no EHV1.
- Team Competition Category added, Income of \$1500 and Expense of \$1500.
- Adult Amateur Category added, Income of \$4000 and Expense of \$4500 to reflect RMDS budgeting \$500 for AAs to use, similar to Jr/Yrs.
