BE SURE TO NOTIFY THE RMDS SECRETARY OF THE NAMES OF ALL THE DELEGATES AS SOON AS POSSIBLE.

A Chapter shall annually elect from its membership delegates to the Society's Board of Governors. At a Board of Governors meeting, each Chapter shall be entitled to one (1) vote for every twenty (20) members or fraction there-of. Each Chapter shall notify in writing the Secretary of the Society as to how its voting rights are distributed amongst it delegates.

By-Laws

2012 BYLAW & STANDING RULE - SUGGESTED CHANGES

ARTICLE IV.

MEMBERSHIP AND REPRESENTATION

A. Membership:

Upon joining the Society, members shall select a Chapter to represent their interests in forming Society policies and in managing the Society. Should a member fail to select a Chapter, he/she shall be assigned to a Chapter at the discretion of the RMDS Central Office. Members may change Chapter affiliation by notifying the RMDS Central Office in writing of their desire. BOARD

Discussion – allowing at large directors and why yes or no... we're leaving it in. straw pole shows that board supports people not having to have a chapter. 1 – Office assigns 2 people. 2 – Don't have to belong to a chapter 7 people. 3 – I don't care 4 people. Wording to be sent forward for publication in the Centaur: Should a member fail to select a Chapter, he/she shall remain a member at large and will not have Board of Governors representation.

- B. Chapters:
 - 3. All members of a Chapter must be members of the Society in good standing.

if a Chapter board member who is elected by the membership is not a member of RMDS in good standing by the January RMDS Board meeting they can not take office and will not be included in the D&O and not recognized as a board member (RMDS or Chapter) and no other board member can take that responsibility unless elected by the membership or EB. BOARD

Discussion – this is a complete addition. Leave it as is and send before the board of governors.

ARTICLE VII. OFFICERS

- A. The elected officers of the Board of Governors being, President, Vice President, Secretary, and Treasurer, shall act in their respective capacities as the officers of the Society. All officers shall be members of the Society in good standing and a participating member of the United States Dressage Federation.
- B. Term of Office:
 - 4. The Vice President shall be elected to a 1-year term to begin January 1. Limit term if not moving up? Limited to 2 consecutive terms.
- D. President:
 - 4. In the event the president is unable to complete their term, the Office shall normally be filled by the ascension of the Vice President. In the event the office of Vice-President is either vacant or held by an appointee of the Executive Board, the office of President shall be filled within 30 days by an election of the Board of Governors and shall fulfill the remainder of the term.

ARTICLE VIII. COMMITTEES

- A. Permanent Committees:
 - 3. The responsibilities of the Permanent Committees relate to coordination of the major activities of the Society.
 - c. THE SHOW COMMITTEE shall be responsible for RMDS Championship Competition as outlined in the Standing Rules Section XIV. BOARD

Deleted: Championship

ARTICLE IX. EXECUTIVE BOARD

A. The Executive Board shall consist of the four elected Officers, the Chairpersons of the Permanent Committees, the immediate past President of the Society, and the President of each non-suspended Chapter. Executive Board members shall not hold a chair position for which they receive remuneration for activities related to that committee. Nor shall they hold a proxy for that chair position. The Central Office Manager shall not hold a board position or carry proxies. Laura approves to go before the BOG.

RMDS Standing Rules

SECTION III. RMDS RECOGNIZED/APPROVED COMPETITIONS

M. RMDS Recognized Competition Approval:

 Chapter sponsored competitions that are presented and recognized at the RMDS Fall Board of Governors meeting shall have their dates protected for ONE year. BOARD

SECTION V. AWARDS - YEAR END

A. Eligibility:

- Only current members of the Society in good standing shall be eligible to receive Society Year End Awards
 - Members who have failed to return or make restitution for missing/damage perpetual trophies from previous years, by Oct 20, shall not be considered in good standing and will therefore not be eligible for Society Year End Awards.
 - b. Members must complete 4 hours of documented volunteer hours in order to be eligible for any yearend award. Members should submit proof of volunteer hours to the central office by October 1.

8. In order to receive a year-end award, you must volunteer 4 hours at an RMDS recognized show or event during the current season. If you are unable to do this, someone may do this for you. A volunteer form must be filled out, signed by the organizer of the event and submitted to the Central Office by October 1 of the same year.

- E. Perpetual Trophies:
 - Perpetual trophies are the property of RMDS and are loaned to the recipient contingent upon the signing of a contract specifying penalties for late return, damage or loss of the trophy. Trophies must be returned by Oct.
 to the RMDS Awards Chairperson. A keeper ribbon will be provided by RMDS.
 - If the trophy is not returned by October 1, a fine of \$25 will be assessed. If the trophy is not retuned by
 October 20, it will be considered lost and the recipient will be required to pay for a replacement trophy.

SECTION VI. RMDS TECHNICAL DELEGATES PROGRAM

- B. RMDS Technical Delegates Continuing Recognition Requirements RMDS Technical Delegates who meet the following conditions shall be approved to continue to officiate at competitions recognized only by RMDS.
 - 6. An RMDS Technical Delegate must take a technical delegate's exam once every two (2) years and must receive a mark of 85% or better before their certificate is renewed. The test is to be administered in October of the odd numbered years.
 - 7. If test is not passed, must do whole program again: as stated in Section VI, A. above. BOARD

RMDS CHAMPIONSHIP SHOW

A. General:

- 6. Horse and rider combinations, which are champions from previous years and received an RMDS qualifying score in that championship class for Training Level through Fourth Level & Training through Fourth Level Freestyle, are not eligible to compete again in Championship Classes at the same level at which they were champions.

 BOARD
- 7. Except for Musical Freestyle Classes, the Annual Level Champions for Adult Amateur, JR/YR, and Open divisions will be determined by riding the highest test at the level that shall be judged by at least two (2) judges. The horse and rider combination with the highest average for each division at each level shall be the champions.
- 8. Musical Freestyle Level Champions shall be determined by riding a single freestyle test at the qualified level that shall be judged by at least two (2) judges. The horse/rider combination with the highest average score for the test at each level shall be the champion.
- 9. Only the rider that has qualified on a specific horse may ride that horse during the Championship Show (Only 1 rider per horse for the show) (groom with a loose rein excepted).
- 10. The championship awards shall be presented at the Championship Show in a formal awards ceremony. Failure of the horse and rider recipients to appear in costume and full tack for the ceremony (unless excused for cause by the show management) shall result in immediate disqualification. In event of disqualification, each affected award shall be presented to the next lower average score.
- 11. No whip may be carried by a rider in an RMDS Championship Class. (Exception: Riders riding sidesaddle may carry a whip in RMDS Championships.)
- 12. Championship tests must be ridden from memory.
- 13. Rider must submit a copy of their current US Equestrian Federation Adult Amateur card to be eligible to ride as an Adult Amateur.
- 14. In the event of a tie for Champion or Reserve Champion, the collective marks will determine 1st, 2nd and 3rd place. Otherwise a tie will remain unbroken.
- B. Qualification for Dressage Championship Classes:

Championship Classes shall be open to all Society members in good standing who meet the qualifying criteria specified below:

- 5. Horse/rider combinations may qualify for Championship Classes by submitting scores meeting the following criteria:
 - b. The horse/rider combination must receive two (2) qualifying scores from RMDS recognized competitions at the level of the Championship Class that they wish to qualify to ride in the current RMDS show year; one of the tests must be the highest test at that level. The scores must be from two (2) different judges at two (2) different shows. The minimum qualifying score for each level for RMDS Championships ONLY shall be: Not to exceed USDF requirements) BOARD

Communications by Nicole Bizzarro

So much going on! We have a lot of things to review:

Centaur—Advertising is down! Lori has offered a lot of suggestions for changes to the regular sections such as, a Book Review, Spotlight on the Board, Ask a Professional, Trainer Spotlight…etc. But there seems to be a good amount of articles and content in each issue…just not enough ads. Cathy states: "The last thing I'd like to mention is that the Centaur needs more advertisers, not necessarily more articles. People like to scan the Centaur, but they don't necessarily read every article. I've looked at a ton of newsletters in the last few years…there are maybe 2-3 short articles per issue, and the rest is the groups' business notifications and ads. RMDS is in dire need of a group of dedicated marketers who are willing to get out there and find some good advertisers…they could also do double duty for the Omnibus. I'm sure RMDS could use the money to offset the production costs of the Centaur and Omnibus."

Lori discussed that indeed she feels we need more content and advertising... pay some college kids who would get a commission on ads sold.

Several members discussed that the content of the Centaur is marginal at best – what can be done outside of getting advertisers to increase the content and educational value of the Centaur to make it valuable to our members? Elaine Haberman suggested adding show results, similar to the California Dressage Society. It was also suggested we offer dirt cheap or free classifieds to our members.

Several board members supported a proposal to go to every other month. Lori tabled this discussion for the meeting in October when we could look at budgetary figures.

Cathy suggested running free classified listings (or dirt cheap, or free for OND) as a way to get people to flip through from the cover to the calendar to the classified section. From Cathy: "If I can make a suggestion as a marketer...start with the classifieds. Some of the GMOs offer almost free classifieds as a membership perk. Get those going and people will start looking at the calendar first and the classifieds next. When the classifieds are rolling (nearly a full page), then people will start buying spendier ads again. It's one of the best and easiest ways to make the Centaur the "go-to" publication for dressage resources. Might take half a year or more, but it'll happen. Just my two cents..."

In other Centaur News, Beth submitted two articles of Cathy's choosing to the annual USDF Newsletter Awards!

Facebook—384 members. Let's try and decide what we will allow other to post on the RMDS FB wall, we have been removing advertising, but this is a tricky judgment call for me most of the time...could we come up with some parameters? Leave all posts up was the feeling of the board.

Omnibus—we expect advertising to be low in the 2013 Edition, and have kept the pricing structure unchanged. We did sell every tab last year but not every tab was sold as a color ad...do we want to make any changes in price or add color ads in section C next year? Or make all tabs color, and therefore more spendy?

Last thoughts—I feel it is EVERY board members duty to help push all advertising for RMDS...we really need to bring up the ad sales to offset the costs of the publications we all value. I would love to see all advertising opportunities given emphasis and have created (and re-created) an RMDS advertising information PDF that has the whole enchilada, from the Web Marketplace to the Championship Program to the Omnibus and Centaur, plus the discounts available...if you are out there pitching one venue, please at least leave information about all the advertising opportunities.
