Notes on Line Items:

For 2014, we will recategorize the Awards Program from the Awards budget to the BOG Banquet.

Awards: Shannon noted for 2014 there will be increased postage rates, several new awards, one replacement trophy needed, it's another Regionals year which will increase rider plaques and plates and also noted that she expects her 2013 budget to be \$750-\$1000 over budget due to a change in vendor and an increase in the number of plaques due to Regionals.

Education/Expo – this is just promotional items and registration for the Colorado Horse Expo.

General Category is State of Colorado Reports and bank interest.

Marketing – in 2013 we paid \$292 to Nicole Bizzarro for design stuff, \$250 for Constant Contact registration, \$172 in supplies for the media kits. We also sold 10 shirts at Championships. There was some discussion of a group advertising effort nationally with Estes Park and the Colorado Horse Park. Hope to find out more when we sign Championships contracts.
