## Budgeting Session Sharon Soos

- Discussion of how the budgeting sheets work and packet material.
- Adult Amateur 2018 we didn't budget income/expense but we did have a clinic. For 2019 we will do no income and \$500 expense as nothing is currently planned.
- Allocate \$500 to Juniors, Amateurs and Professionals.
- Awards Shannon thinks we should decrease the income budget since we mail out less and there is less postage reimbursement coming in. \$400 Income suggested. Expenses \$6500 with the storage unit and such.
- BOG Banquet Meals up a little bit for expense. Auction crew a bit different so not counting on the income as much. \$8500 income, \$8500 expense. Working to make it be a break even and hoping for a good income. Stephanie will be the collection point for donations.
- BOG Meeting \$1900 expense.
- Centaur numbers lower than the budget in 2018. Discussion of further decreasing issues? It was thought to stay at 6 issues. \$5000 Income, \$14,500 expense. \$9500 loss. Have to include postage increase.
- Central Office Email blasts. \$3000 income, \$13000 expense. \$10000 loss.
- Championships Region year. \$125,000 expenses. \$125,000 income.
- Education/Clinics –Quickbooks needs to be laid out a little differently and Sharon is working on fixing this. This category is shifting a little bit. \$2000 income, \$2000 expense.
- Junior Program \$500 expense budgeted for their use.
- Junior Camp Not as much of a profit as previous times we hosted due to bigger clinicians. \$3500 income, \$3500 expense. Break even.
- Marketing/Expo get post-it notes for Expo again, hats dressage with altitude again to sell and have available at shows. \$750 Income, \$1000 expense. \$250 loss.

- Membership dues \$45,000 income, \$22,500 expense. \$22,500 profit.
- Horse dues \$6600 income. \$6600 profit.
- Donations \$2785 expenses same as 2018.
- Misc/paypal \$500 in paypal income from fees and such. \$500 loss. It's a wash.
- Omnibus Almost broke even in 2018. Still budget for a slight loss for 2019. \$14000 income, \$16000 expense. \$2000 loss.
- Operating (USDF Convention/Treasurer expenses) \$3000 expense \$2000 convention expenses, \$1000 mis and treasurer stuff. \$3000 loss.
- Professionals \$500 budget for them to spend on activities.
- Scheduling/Insurance show recognitions, insurance for club and chapters if asked for it. \$2500 income, \$2000 expense. \$500 gain.
- Scholarship \$2000 expense, \$1500 income. \$500 loss.
- Taxes/Legal/Audit Chapters are down. \$225 income, \$5625 expense. \$5400 loss.
- Team Competition \$2300 income, \$1000 expense.
- Website \$1625 expense, \$300 income. \$1325 loss. We need to follow up on the sponsorships promised from 2017 for 2018. Website Premier trainer sponsorships \$250 for pro dinner sponsorship, \$30 to the marketplace ad on the website and \$20 to the ¼ page centaur ad featuring our premier trainer sponsors.
- General / Interest \$100 both misc stuff.
