CodeGeek

- Scoping: Our final piece to finish detailed scoping on is the results/awards/reporting functionality, which includes any exports from the site, such as email lists and membership rosters. We're working with Beth to finalize the requirements of that portion of the application.
- Wireframes: We reviewed our second to last wireframes of the project, which covered how shows and scores are entered into the system. The final wireframes will be for the results, awards and reporting pieces.
- Design: We're finalizing interior page designs (for the public facing website) and will be ready to share those with the team soon. That will wrap up the bulk of the design work on this project.
- Development: We're in the heart of development for the public facing web pages, and have started to wrap up the membership signup and payment processes. Next steps will be to move the site to a development server so that we can start to QA those sections and enter content on the website, while the developer team moves on to the admin functionality of the site.
